Based upon the results of the audition, the Choral faculty may require additional coursework in French, German, Italian, English, or Latin diction or reading knowledge in one or more language.

Any UW-Madison course numbered 300 or above will count for graduate credit. 50% of course work in the program must have the graduate attribute. A maximum of six credits of course requirements may be waived by the Mead Witter School of Music Curriculum Committee on the basis of previous coursework that is judged to be equivalent to that at UW-Madison. Waived credits do not count toward a UW-Madison Degree.

sMinimum Graduate Degree Credit Requirement

The Graduate School's minimum graduate degree credit requirement is a degree requirement instituted by the Graduate Faculty Executive Committee to ensure that a graduate degree meets institution accreditation standards (this includes but is not limited to online, thesis/research, independent study, and practicum internships credits).

Minimum Graduate Degree Credit Requirement: 30 credits

Minimum Graduate Residence Credit Requirement

The Graduate School's minimum graduate residence credit requirement for graduation can be satisfied only with courses numbered 300 and above taken as a graduate student at UW-Madison (this includes but is not limited to online, thesis/research, independent study, practicum/internship credits).

Minimum Graduate Residence Credit Requirement: 16 credits

In rare circumstances, courses taken as a University Special student may be allowed to count toward the minimum graduate residence credit requirement. These credits generally are not allowed to count toward the 50% graduate coursework minimum.

Credits applied to the minimum graduate residence credit requirement must be earned while enrolled as a graduate student at UW-Madison and can also count toward the minimum graduate degree credit requirement.
